

Minutes of the 11th Annual General Meeting of Kampong Hash House Harriers on 15th May 2010 at Chye Lye Restaurant, 1 Jalan Legundi, Singapore 759263

1. Opening of the AGM

Having reached a quorum, outgoing President James Eller called the AGM to order at 1635hrs.

2. Confirmation of the Minutes of the Last AGM
