

MINUTES OF THE 15TH ANNUAL GENERAL MEETING OF KAMPONG HASH HOUSE HARRIERS ON 15TH FEBRUARY 2014 AT JIMM'S PUB, 301 CANBERRA ROAD, SINGAPORE 759774

1. Opening of the AGM

7. Incoming President's Address

8. Appointment of Auditors for 2014

Francis Teoh proposed and Silvarajoo Munisamy seconded the motion that Michael Smith and Tony Newling be appointed as auditors for 2014.

9. Appointment of Bank Signatories for 2014

The resolution that bank signatories be changed in accordance with the newly elected committee, namely the President (Teoh Hock Lye, Francis), Hon Secretary (Bina Bhattacharyya) and Treasurer (Kavita Kaur) was passed and accepted by all. This was proposed by Amy Teoh and seconded by Graham Sofio.

10. New Matters

Tony Findlay proposed to pass a resolution to increase members' fees by \$20 per year for men and \$40 per year for women. The new subs inclusive of \$10 insurance would be \$190 per year for men, and \$130 per year for women. This was to cope with rising costs.

Michael Smith noted that the club did not incur losses last year. Aqua's run also broke even.

Tom Lillig pointed out that there were limits within the constitution when fees are affected.

Amy Lin commented that effort should be made to bring in more members and guests to contain costs.

All members accepted the proposal and unanimously passed the resolution, to be made effective in 2015.
